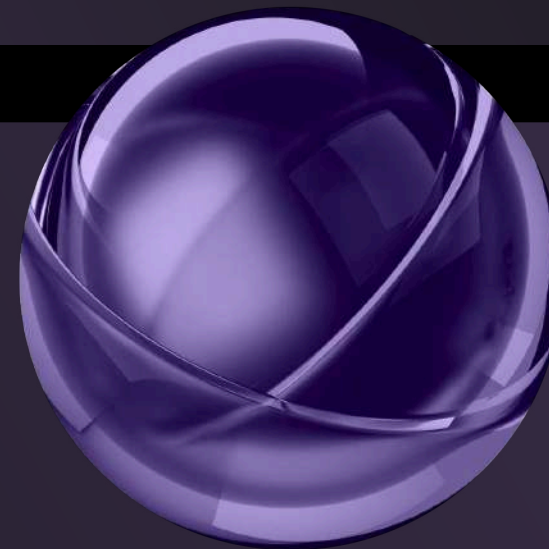

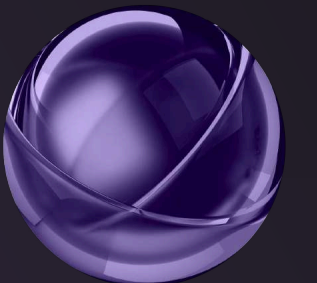
The total crypto market cap was around \$1.2 trillion in 2023, then climbing to \$3.29 trillion in 2025 represents about a 174% increase over two years.

Comparison with Traditional Investments



Bonds

The yield on 10-year U.S. Treasury bonds for 2024 is about 4.5%.

Gold

Over the past 5 years, investments in gold have yielded about 6–8% per year.

Real Estate

Average annual returns on real estate investments are around 8–12%

Stocks

The S&P 500, one of the main indicators of the U.S. stock market, has shown an average annual return of about 10–15% over the last 5 years.

Crypto

The average annual return of Bitcoin over the past 5 years has been around 50% per annum. In 2023, the overall cryptocurrency market grew by 108%.



Fund Strategy

The fund builds long-term and medium-term positions in cryptocurrency assets based on fundamental project analysis, taking into account both economic and technical indicators.

Fundamental indicators include evaluating the project team, investors, liquidity on CEX and DEX exchanges, trading volumes, the number of Web3 applications (in the case of a blockchain), as well as the number of real users.

Technical indicators cover the blockchain's operational speed, its technical state and stability, as well as the degree of the project's integration into the crypto infrastructure, including wallets and Web3 services.

Purchases and sales are carried out gradually, taking into account market conditions. Up to 30% of the fund's capital will be held in stablecoins (USDT, USDC, DAI), which can be used to acquire additional assets, followed by restoring this portion back into stablecoins.

The fund may use stablecoins and other assets in Web3 applications to increase the volume of its holdings, but no more than 30% of the fund's assets will be utilized this way.

A full conversion to stablecoins is possible if the fund's expert board determines that the market is in a distribution phase and that holding assets is no longer advisable.

Portfolio Formation Rules:

1. Asset diversification.
2. Inclusion of fundamentally strong projects.
3. No single asset should account for more than 20% of the portfolio, with the exception of BTC and ETH.

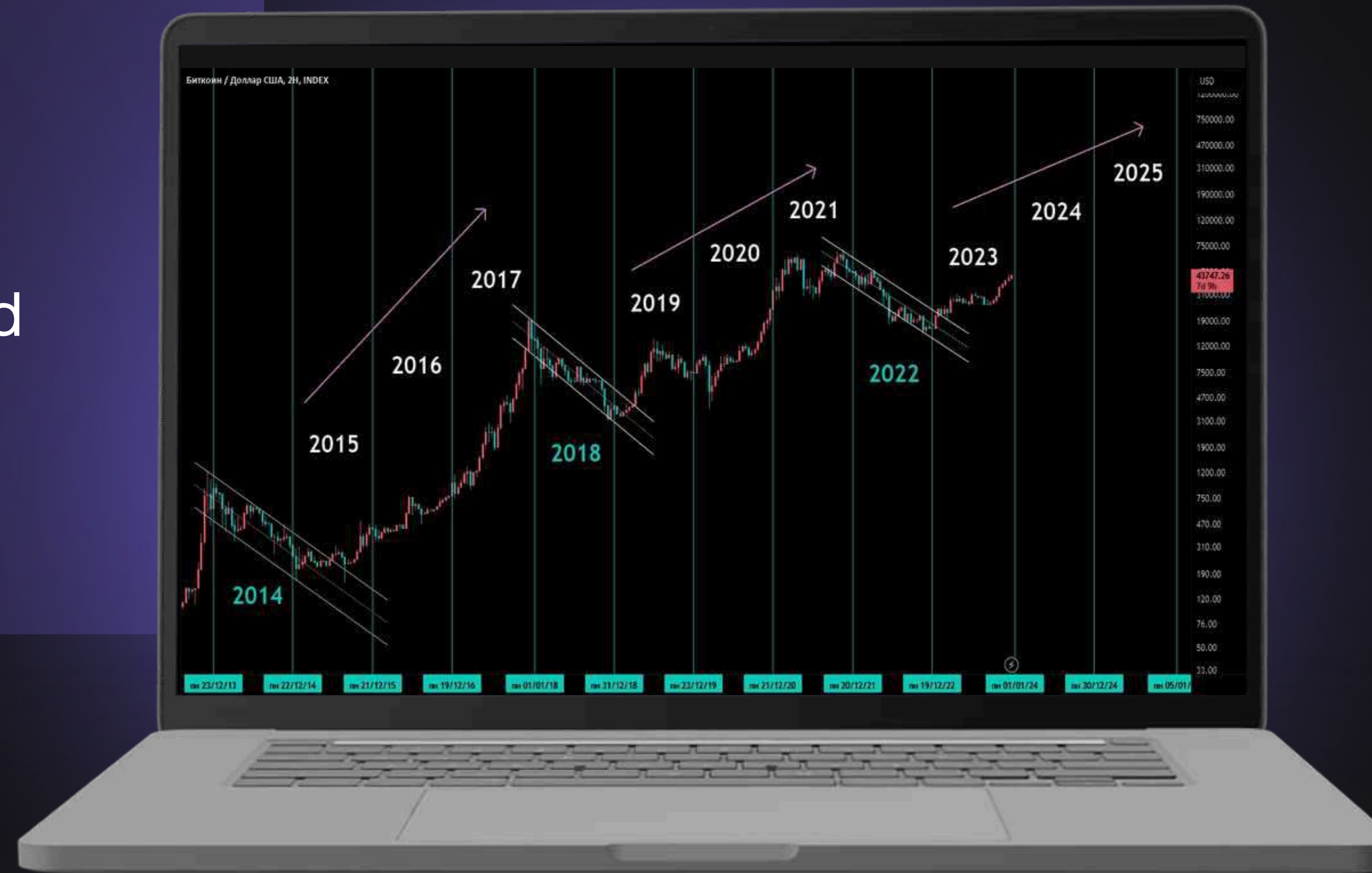
